



## Application for registration as a Veterinarian in New Zealand

(Under Trans Tasman Mutual Recognition Act (TTMRA) 1997)

### Who should use this form?

Veterinarians who are registered in Australia can use this form to apply for registration in New Zealand under TTMRA. All other applicants must:

- use the general registration application form; or
  - (if they are new Massey graduates) use the Massey New Graduate Registration application form
- Both forms are available at [www.vetcouncil.org.nz](http://www.vetcouncil.org.nz) and on request from the Veterinary Council offices

### TTMRA provisions

The TTMRA 1997 recognises Australian and New Zealand registration standards as equivalent and enhances the freedom of registered professionals to work in either country.

Under TTMRA if you are registered as a veterinarian in any Australian state you are entitled, after applying to the Veterinary Council to be registered in the same occupation in New Zealand.

Trans-Tasman Mutual Recognition therefore provides an alternative avenue for obtaining registration in New Zealand. Applicants have the choice of applying for registration under the TTMRA or under the Veterinarians Act 2005

### Application Process under TTMRA

You need to complete the following application form and send it with the required fees and documentation to the Veterinary Council.

Before approving your application and issuing a practising certificate the Veterinary Council must:

- be satisfied that you are currently registered to practise in the participating Australian jurisdiction/s in which you are already registered
- be satisfied that your original registration is not cancelled or suspended due to disciplinary action and that you are not the subject of any such action, or in any other way prohibited or restricted from practising
- be satisfied that you are not the subject of any disciplinary proceedings or any preliminary action that might lead to disciplinary proceedings
- be aware, if applicable, of any conditions imposed on your existing registration
- be authorised by you to make inquiries and exchange information with Australian registration authorities regarding your existing registration
- be satisfied that you meet minimum fitness and recency of practice requirements (refer to [www.vetcouncil.org.nz/pubs](http://www.vetcouncil.org.nz/pubs) for Policy on Recency of Practice and Gazette Notice on Minimum Standards for Practising)
- receive the current registration application and annual practising certificate fee.

These requirements are detailed in the registration application form.

Registration may be postponed or refused if all the documents and information detailed above is not provided.

Upon receipt of your completed application, required documentation and fees we will make inquiries of the Australian boards you are registered with to confirm the statements you have made in your application.

If you are registered or practising in any jurisdictions outside Australia we require you to arrange for a Letter of Good Standing to be sent directly to us.

Under TTMRA the Council must make a decision within one month of receiving your application to:

- grant registration; or
- postpone registration; or
- grant registration subject to conditions necessary to achieve equivalence
- refuse registration if it decides that the occupation is not equivalent

Pending the grant or refusal of registration, you are deemed to be registered and are entitled to practise in New Zealand as a veterinarian. You must however hold an annual practising certificate. The registration application which follows also serves as your annual practising certificate application.

Deemed registration will continue until:

- substantive registration is granted; or
- registration has been refused

The Council may impose conditions on your deemed or substantive registration to replicate any conditions that apply to your Australian registration or to achieve equivalence with New Zealand practising requirements.

Substantive registration will generally be granted within one month of receiving your registration application. Your entitlement to registration in New Zealand will continue whether or not your registration in your original jurisdiction ceases. However the Council may suspend or terminate your registration if you have had your registration suspended or terminated in any Australian state or are otherwise prohibited from practising as a result of criminal, civil or disciplinary proceedings in any jurisdiction

You will be advised in writing of any decision to refuse, postpone or impose conditions on your registration. The advice will set out full reasons and advise you of your right to appeal against the decision. A decision to refuse registration on the grounds of lack of equivalence does not affect your deemed registration for two weeks after you have been notified of the decision.

### **Important notes**

This application form is a legal document. Please print all answers clearly and **do not** use correction fluid or tape. Any error should be crossed out and initialled.

All applicants must complete the application carefully and honestly. Under TTMRA the Council may postpone or refuse the grant of registration if:

- any of the statements or information in your application are false or misleading; or
- any document or information provided in your application is false or misleading; or
- any document required has not been provided; or
- it determines that your veterinary registration in Australia is not equivalent to veterinary registration in New Zealand, and that equivalence cannot be achieved by the imposition of conditions
- your circumstances have changed since the date of your application

The information you give in this application is covered by a statutory declaration which must be declared in front of a person authorised to administer an oath for the purpose of statutory proceedings. In Australia statutory declarations must be made before a Judge, a Commissioner of Oaths, a notary public, or a Justice of the Peace or any person authorised by the law of Australia to administer an oath there for the purposes of a judicial proceeding, or before a Commonwealth representative, or before a solicitor of the High Court. In New Zealand Notaries Public and Justices of the Peace are listed in the Yellow Pages of the telephone directory.. The certification must state your full name, the date, and include the stamp of the certifying officer and their signature. Certification should be directly on the copied document and not on any attached sheet.

We prefer not to receive original documents as they require special care. All copies of your documents must be certified or notarised as true copies of the originals by the official who witnesses your statutory declaration. This person must also sight and certify a copy of the identification pages of your passport and certify the required photograph as a true likeness of you.

Please use the checklist at the back of this application to ensure you have enclosed the correct fees, all relevant documents and that you have **completed all sections**. By ensuring all documents are copied, certified correctly and enclosed with the application the registration process can be undertaken quickly. Incomplete applications may be returned to you for completion.

If you wish to practise in New Zealand before the start of the next practising year on 1 April you must also hold a current annual practising certificate (APC). It is illegal to practise in New Zealand without being registered and holding a current APC. This registration application also acts as your application for an APC.

Fee for Annual Practising Certificate for those registering between April and June: NZ\$420.00  
(This covers the period to 31 March and is refundable if registration is not approved)

Fee for Annual Practising Certificate for those registering between July and September: NZ\$371.00  
(This covers the period to 31 March and is refundable if registration is not approved)

Fee for Annual Practising Certificate for those registering between October and December: NZ\$266.00  
(This covers the period to 31 March and is refundable if registration is not approved)

Fee for Annual Practising Certificate for those registering between January and March: NZ\$161.00  
(This covers the period to 31 March and is refundable if registration is not approved)

If you do not wish to practise in New Zealand until after the start of the next practising year on 1 April, we require you to pay a non practising fee to cover the costs of maintaining your name on the Register of Veterinarians
